4. Chair's report

5. Treasurer's report

The treasurer report was shared live on screen. The report on expenditure and income had already been circulated to membership and will in due course appear in the newsletter. ALG's income comes entirely frommembership subscriptions. We currently have 86 paid members, mainly from Europe and Scandinavia, with a few from USA and Canada, and a single member from China and Russia respectively. ALG has a healthy bank account balance and there is no need to increase the subscription (£10 or £12 if paying by paypal).

Expenditure for ALG include newsletter costs, paypal and zoom subscriptions. In future committee may decide to use some of the surplus for events (speaker's costs) or publications.

6. Editor's report

Since the last AGM, there have been two newsletters. The September '22 had diverse content and the March '23 issue was a special issue for Roy Thomson. This was made possible by images sent in by ALG members, especially Dominque Mathieu who supplied many of the images used in the special issue.

ALG is still receiving enquiries on archaeological leather and we will continue printing the answers.

A new feature was introduced in autumn '22: Getting to Know our Members. We have featured 2 members so far and will continue featuring more in due course.
